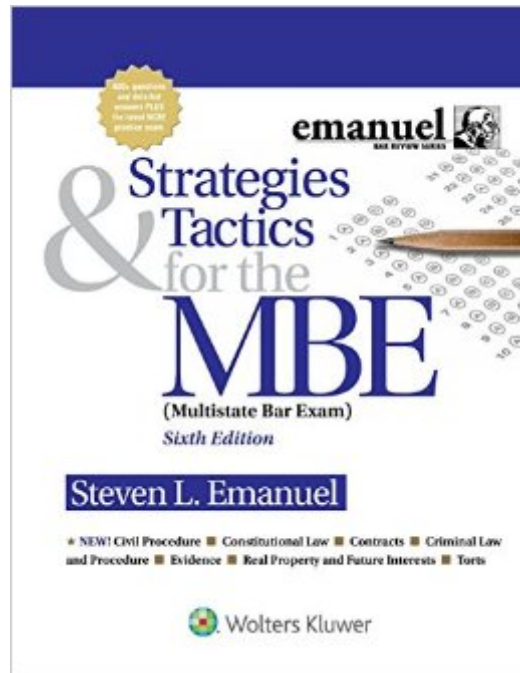

I received this book two days ago and have probably spent about 6-7 hours total with it so far. It is

good. It is helpful, and I would recommend it. But, I had to stop, mid-study, to write this review because there are numerous typographical errors. There are some that are normal, that you could easily glance over and it would make no big deal, but there are others that affect the outcome of an answer. Huge confidence blow, and not something you would expect from an \$80 book designed to help you choose correct answers, no matter how long and dense it is.

I tutor the MBE and have published a book to help students prepare for the MBE. Both the strategies and the questions in this book make it an essential component of any studying plan.
